ESSENTIAL DUTIES AND RESPONSIBILITIES To perform this job successfully, an individual must be able to perform the essential duties satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required.

- Use of hand and power tools to perform a wide range of landscape and irrigation duties
- Use of edger, weed whip, and walk behind mower
- Operate and maintain riding lawnmower or zero-turn mower
- Ability to determine wanted and unwanted vegetation
- Following safety practices
- Cleanup of job sites; consisting of debris, household materials, etc.
- Carry a sense of urgency to assure work is done in a timely manner
- Work for extended periods of time in various weather conditions

Other Essential Skills:

- Ability to use power and hand tools
- Ability to teach and train new laborers
- Ability to follow plans as shown on a map of property
- Wear and operate backpack blower

Job Qualifications:

- Previous lawn care experience is preferred, but not required
- Valid Driver License or Chauffer License with MDOT card is encouraged
- Due to the inherently dangerous nature of the industry and the requirements to work with or around hazardous equipment, employees must be able to maintain attention and concentration for extended periods of time
- Must be able to wear PPE as necessary
- Must be able to enter and exit a vehicle numerous times a day
- Must be able to withstand exposure to all kinds of weather while completing work assignments, i.e., rain, heat, sun, cold
- Must be able to traverse various terrains
- Must be able to write, read and comprehend written and verbal job instructions/information
- Must be able to communicate with others
- Must be able to maintain attention during dangerous tasks

- Must have sufficient eyesight to judge distances and coordination to get and use the appropriate equipment and tools
- Must be able to operate all required tools and equipment
- Must have transportation to and from the show up location
